INTRODUCTION

The Mediation and Restorative Justice in Prison Settings (MEREPS) Project is a three year international exchange project funded by the European Commission, between the countries of Germany, Hungary and the UK.

The project will identify, exchange and develop best practice for the use of restorative justice (RJ) with the most serious crimes, particularly those against persons and property attracting a custodial sentence. Research suggests that RJ can have the biggest impact on the lives of victims and offenders where such serious crimes have been committed.

The consortium of international project partners will be involved in a number of activities, including: carrying out original research to gain a deeper insight into the attitudes of victims, juveniles, adult inmates, correctional staff, policy makers, legislators and other key stakeholders towards RJ; and exchanging knowledge of various post-sentencing RJ practices in each of the three countries to encourage learning between the regions.

THE PROJECT PARTNERS



FORESEE RESEARCH GROUP - PROJECT LEADER (HUNGARY) — Foresee Research Group is a recently formed interdisciplinary think tank. As the MEREPS project's consortium leader, **Foresee Research Group** (Hungary) is responsible for the technical and administrative implementation of the project. Concerning the Hungarian activities, Foresee is coordinating the Hungarian pilot project, including organising the training of prison staff as well as carrying out mediation and restorative justice activities in prison settings. Throughout the project Foresee's priority is to stimulate the effective partnership and exchange between the various national and international parties as well as to coordinate the dissemination of the results.

The **Innokut Researching Ltd.** (Hungary) is supporting Foresee Research Group in the financial administration of the project.

The Hungarian **National Institute of Criminology**, as the professional leader of the project, is responsible for carrying out a quantitative and qualitative empirical research concerning the attitudes of inmates and prison staff towards restorative justice.

IARS (UK) carries out a UK based research project on the post-sentence use of RJ with young offenders. IARS will conduct interviews with policy makers, correctional staff, and young people to identify emerging themes and examples of best practice. IARS is organising and hosting the study tour and first expert meeting in London in November 2009.

The German partners, the **HfoeV University** and the **Victim-Offender Mediation Service** in Bremen will carry out and evaluate victim-offender mediations in prison settings as well as will deliver an attitudinal research about the judiciary's view towards RJ.

With the help of the **European Forum for Restorative Justice** the MEREPS project's main objective is to internationally exchange the results of the above mentioned pilot and research projects. Via the national reports and the MEREPS web portal the project intends to help the European-level best practices and policy, including the future methodological, institutional and legislative developments.
